
Dear Friends:

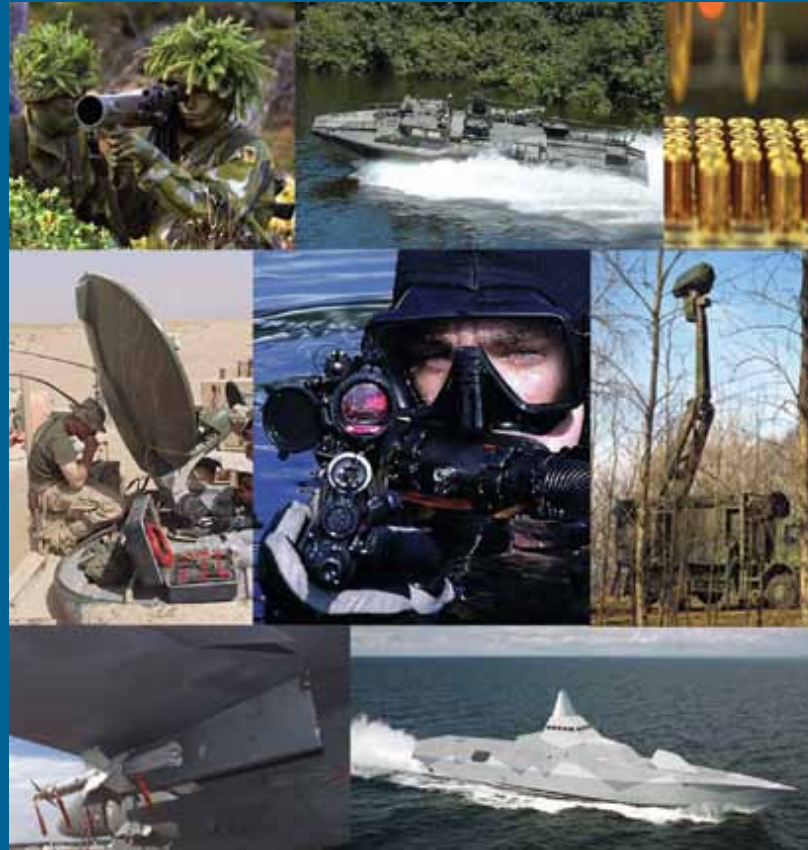

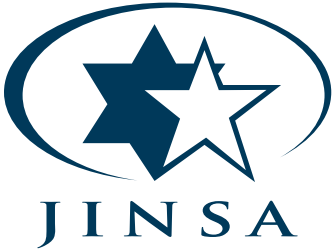

Speakers

Steven A. Austin is Director, Planning and Analysis in the office of the Under Secretary of Defense (Acquisition, Technology and Logistics)/Office of the Director (International Cooperation). He oversees DoD planning for international research, development, and acquisition programs; and manages the Defense process for negotiation and approval of international agreements for defense acquisition programs. He also formulates positions for the Under Secretary of Defense (Acquisition, Technology, and Logistics) on issues relating to security assistance, national disclosure policy, munitions export licenses, and other armaments cooperation transfers of U.S. defense technology. Mr. Austin received the Bachelor of Science degree in Electrical Engineering from Louisiana Tech University and the Master of Engineering degree in Industrial Engineering from Texas A&M University. He also has completed the Program for Senior Executives in National and International Security at Harvard University.

The Hon. Jeffrey P. Bialos is Executive Director of the Program on Transatlantic Security and Industry at the Center for Transatlantic Relations at Johns Hopkins University's School of Advanced International Studies. Mr. Bialos is also a partner in the national law firm of Sutherland Asbill, and Brennan and a senior advisor to JSA Partners. Prior to his current activities, Mr. Bialos served in several senior U.S. government positions. Most recently, he was Deputy Under Secretary of Defense for Industrial Affairs (Sept. 1999-Jan. 2001). Mr. Bialos received his J.D. degree from the University of Chicago Law School, a Master's degree in Public Policy from the Kennedy School of Government at Harvard University, and an A.B. in history, magna cum laude, from Cornell University's College of Arts and Sciences.

Lars Bjerde is Executive Vice President. Head of Strategy and Business Development, Saab North America Inc. From 2008-2010, Mr. Bjerde was Senior Vice President and Advisor to the President and CEO of the Saab Group. Saab Technologies Inc. From 2006-2008, Mr. Bjerde was President and CEO SWE-DISH Satellite Systems Inc, VA. He managed the company to be successfully acquired in 2007 and it is now traded on the NY Stock Exchange. From 2001-2006, Mr. Bjerde was VP and General Manager North America, Ericsson Inc. He established in 2001 Ericsson Microwave Systems in the North American market and launched a major sales initiative regarding radar and telecom systems and strategic co-operation opportunities. From 1988-2001, Mr. Bjerde was Counsellor for Defence Cooperation, Embassy of Sweden, DC. He is a Director and board member of various corporations, committees and organizations (e.g. Defense Corporation, Trade Council, SACC).

Susan L. Coté is vice president of corporate contracts, pricing and supply chain at Northrop Grumman Corporation. In this role, she is responsible for corporate business management functions including contracts, pricing, supply chain and export/import compliance. She is also responsible for enterprise socio-economic business planning, strategy and compliance relative to the supply chain. She chairs the Supply Chain Leadership Council, which serves as the principal governance body for the supply chain function, comprised of sector supply chain vice presidents. Prior to joining Northrop Grumman, Coté held various contracting positions within the United States Air Force. She served at HQ Space Division (Los Angeles AFB), HQ Air Force Systems Command (Andrews AFB), and HQ USAF (Pentagon). She entered government service through the Presidential Management Intern Program. A graduate of Principia College, Illinois, Coté earned a bachelor's degree in political science and a master's degree in Public Administration from the University of Arizona.

Christoph Ebell serves as the science and technology counselor at the Swiss Embassy in Washington, D.C. Before his posting in the United States, Ebell worked at the Department of Economic Affairs in Bern, Switzerland, where he headed the international cooperation section for innovation, education and international organizations. Specializing in innovation policy issues, he was a delegate at the OECD Committee for science and technology policy, UN commissions, and a member of several working groups, including the expert panel on the OECD Innovation Strategy. Prior to that, Chris has built up extensive experience with R&D-related EU institutions and multilateral cooperation mechanisms both on a European and global level with an emphasis on advanced manufacturing. Before joining the government services, Chris did research in American and Afro-American studies and culture in Switzerland and at Harvard University. He received Masters degrees from the University of Bern and from the University of Illinois at Chicago.

Ron Genemans is the Defense Cooperation Attaché at the Embassy of The Netherlands. He assumed this position in July 2009. In his previous assignments Mr. Genemans served as a senior policy advisor to the Netherlands Minister of Defence. In earlier positions he worked at the Arms Export Control Department of the Netherlands Ministry of Economic Affairs, the Netherlands Military Intelligence Service and the Royal Netherlands Air Force. In 2005 he worked as an industrial analyst for the Deputy Under Secretary of Defence for Industrial Policy at the US Department of Defense in Washington DC. Ron Genemans is the current Chairman of the Defense MOU Attachés Group (DMAG), a group of 21 countries with bilateral reciprocal defense procurement agreements with the US.

Stuart A. Hazlett, member of the Senior Executive Service, assumed the position Deputy Director of Program Acquisition & Strategic Sourcing (PASS) for Defense Procurement and Acquisition Policy (DPAP) in February 2007. In June 2011, he also assumed the position of Deputy Director of Defense Pricing (DP). He accordingly serves as a senior advisor to the Directors of DP, DPAP, and the Under Secretary of Defense for Acquisitions, Technology, and Logistics. Mr. Hazlett is responsible for program execution of all major program acquisitions and strategic sourcing efforts across the Department. Mr. Hazlett serves as the Chair of the Strategic Sourcing Directors Board (SSDB) and the department's representative to the Federal Chief Acquisition Officer Council Strategic Sourcing Working Group. Mr. Hazlett holds a Bachelor of Arts degree from Ohio Northern University and a master's degree from Central Michigan University. He is a 1998 graduate of the Industrial College of the Armed Forces, where he earned a masters degree in national resource management.

Dr. David A. Honey joined the Office of the Assistant Secretary of Defense, Research and Engineering as the Director for Research on 31 August 2009. Dr. Honey is responsible for policy and oversight of DoD Science and Technology programs from Basic Research through Advanced Technology Development. He is also responsible for oversight of DoD laboratories, ensuring the long-term strategic direction of the Department's S&T programs, and for developing those technologies needed for continued technological superiority of US forces. Before assuming this position Dr. Honey was the GM and Senior VP of the Defense Sector for Information Systems Laboratories (ISL). Dr. Honey was the Director of the DARPA, Strategic Technology Office (STO), Director of the Advanced Technology Office (ATO), and Deputy Director and Program Manager of the Microsystems Technology Office (MTO). Dr. Honey is a retired Air Force Lieutenant Colonel who began his military career as a pilot (B-52D/H and FB-111). He received a B.S. in Photographic Science from Rochester Institute of Technology, an M.S. in Optical Science from the University of Arizona, an M.S. in Engineering Physics from the Air Force Institute of Technology (AFIT) and a PhD in Solid State Science from Syracuse University.

Colonel (Armament Corps) Nicolas Hué is Defense Cooperation Attaché, Embassy of France Washington, D.C. He graduated in 1987 from France's top engineering school Ecole Polytechnique, in Paris, France.
