### 1-2 FEBRUARY AT PACIFIC 2006

A unique series of high-level briefings, aimed at giving Australian companies an insight into international markets, will be a major feature of the Pacific 2006 International Maritime Exposition at the Sydney Convention and Exhibition Centre, Darling Harbour.

The briefings are an Australian Government project, jointly managed by the Department of Defence and the Department of Industry, Tourism and Resources with support from Maritime Australia Limited.

They are being held on Wednesday and Thursday 1-2 February under the banner of the Global Maritime Business Forum.

The Forum is aimed at assisting Australian firms to market their capabilities to large international defence and maritime suppliers and service providers.

The structured program will give Australian companies a clear understanding of the requirements of the international marketplace. It will also enable foreign companies to quickly and efficiently identify Australian capabilities they may wish to access.

The briefings will be conducted in two parts:

 A series of public presentations by foreign companies detailing their supply chain requirements and proposed future projects that may be of interest to local suppliers, and

 A series of one-on-one briefings where Australian companies can make a short (about 15 minute), personal presentation to potential overseas customers.

A feature of the public briefings will be presentations on the Amphibious Ship Project and the Air Warfare Destroyer Project.
